PRESENTATION OF THE COMPANY EURO LINE LTD.

Euro Line Ltd. is registered in 2005 for the wholesale, production, storage, distribution, processing, packaging and freezing of the fruits, vegetables and food products.

In 2009 we built a business and distribution center of 1.3 hectares in Vuckovica, Knic municipality, the region of Sumadija, in Central Serbia.



Our fleet includes 34 trucks and commercial vehicles in the cold storage category.



In the years 2017 and 2021 we invested funds in the construction of two cold storage buildings, in accordance with the latest standards for the reception, storage, processing and distribution of food products.



The total storage capacity of Euro Line Ltd. is 2,228 t / 2,785 pallet places, as follows:

COLD STORAGE BUILDING 1:

- 28t / 35 pallets in the shock chamber 24h,
- 800 t / 1,000 pallets in minus mode up to -20 ° C,
- 160 t / 200 pallets in cold mode 2 ° C to 4 ° C and
- 280 t / 350 pallets in storage space without temperature regime.

COLD STORAGE BUILDING 2:


- 960 t/1.200 pallets in plus and minus regime.

Cold storage buildings are equipped with machines and equipment for cutting and packaging of fruits, vegetables and foodstuffs.

We have also invested in the purchase of new machines and equipment for cutting and packaging of the fruits, vegetables and foodstuffs with the aim of market placement of new items in protected, vacuum, sliced and grated packaging with a longer shelf life, which have a growing demand, and are made under controlled HACCP and hygiene standards.



We are certified with HACCP standard.



In the year 2021 Euro Line Ltd. operated with an annual revenue of 7.42 mill. euro.
 In 2022 with 10,27 mill. euro (39% increase).
 In 2023 with 12,71 mill. euro (24% increase).

OUR REFERENCES

We can put our sales channels in the service for a potential partner. Our sales network with 13 sales representatives and 92 employees, covering the entire Serbia, contacts and positions in national retail chains, all sales channels and customers can be put on disposal to sell products of potential partner.
